


2013 American Electric Power Foundation Annual Report

The AEP Foundation complements a tradition of corporate philanthropy exhibited by American Electric Power and its regional utilities in support of AEP's community relations goal: "To support and play an active, positive role in the communities where we live and work."

The Foundation provides ongoing resources for charitable initiatives involving higher dollar values and multi-year commitments than AEP's operating companies might be able to provide individually. Funded by AEP and its utility operating units, the Foundation made investments totaling more than \$9 million in 2013 to nearly 150 benefiting organizations and communities in our 11-state service area and beyond.

Meeting community needs in education and basic human needs

The AEP Foundation has a special emphasis on improving lives through education from early childhood through higher education in the areas of science, technology, engineering, math and the environment, and on basic human needs for emergency shelter, affordable housing and the elimination of hunger.

The AEP Foundation in 2013 initiated its signature Credits CountSM dual enrollment program to help students pursue STEM (Science, Technology, Engineering, Mathematics) education and careers while completing a high school diploma. Through a \$5 million, five-year grant to Columbus State Community College Foundation in Ohio, the program will be launched in the Columbus City Schools in the fall of 2014.

The program will help middle school students explore STEM careers and fill in learning gaps so they are ready to take college-level courses while still in high school. By graduation, participating students will have earned credits that count toward a career-ready certificate in a STEM-related field or toward a college degree in fields that may include energy, the environment or information technology. Together, the accumulation of college credits at no cost while in high school and the potential award of college scholarships addresses two of the largest barriers to attaining a college degree – college preparedness and affordability.

Major components of the program include middle school STEM experiences, college readiness assessments, tutoring, and a summer bridge program to enhance English and math skills. The program is designed to be replicated in other locations in the AEP service territory.

The AEP Foundation also addressed basic human needs through a variety of grants, including the following:

- A \$30,000 grant to Hope in Action to support emergency homeless shelter and food programs for individuals and families in southwest Arkansas.
- A \$125,000 grant as part of a two-year pledge to the Community Harvest Food Bank of Northeast Indiana capital campaign to upgrade facilities and equipment, and to expand and enhance food bank operations in the Fort Wayne area.
- A \$75,000 grant to Mountain Valley Charitable Foundation Inc. to support revitalization of the historic Old Elliston
 Fire Station into a community food pantry and thrift shop serving residents of eastern Montgomery County, Virginia.
- A \$25,000 grant to the Goshen Project to provide nutritional weekend meals to at-risk, low-income students in Logan County, West Virginia, through a backpack meals program.
