American Electric Power Service Corporation, on behalf of its affiliates, Oklahoma Transmission Company, Inc. ("OKTCo"), and Southwestern Transmission Company, Inc. ("SWTCo"), hereby submits for filing for informational purposes a 2013 Annual Update to its annual transmission revenue requirements ("Annual Update").

In addition, neither OKTCo nor SWTCo has made any material changes in their accounting policies and practices from those in effect during the previous Rate Year and upon which the current rate is based.
