Meaningful engagement involves listening, learning and seeking opportunities to partner with our stakeholders to incorporate ESJ into the decisions we make about existing and planned facilities, programs and services.

AEP's ESJ Policy

AEP will seek and consider input from potentially impacted parties in our decision-making processes as we:

- Develop new infrastructure to power our communities,
- Transition our existing generation fleet to cleaner energy sources; and
- 3 Deploy new programs, services and technologies.



We are dedicated to proactive, meaningful engagement with our customers and communities to ensure equitable treatment regardless of race, color, ethnicity, national origin, culture, faith, ability or income. We want to provide all communities with the opportunity to understand our proposed activities and discuss their concerns so that we may fully understand and consider the environmental, social and health-related impacts of our decisions. We support the equitable distribution of benefits and impacts associated with our activities, and believe all communities should have access to clean, reliable electricity.
