American Electric Power Service Corporation, on behalf of its affiliates, Oklahoma Transmission Company, Inc. ("OKTCo"), and Southwestern Transmission Company, Inc. ("SWTCo"), hereby submits for filing for informational purposes a 2013 Annual Update to its annual transmission revenue requirements ("Annual Update").

The Annual Update contains no expenses or costs that have been alleged or judged in any administrative or judicial proceeding to be illegal, duplicative, or unnecessary costs that are demonstrably the product of discriminatory employment practices, as defined in 18 C.F.R. § 35.13(b)(7). In addition, neither OKTCo nor SWTCo has made any material changes in their accounting policies and practices from those in effect during the previous Rate Year and upon which the current rate is based.
