American Electric Power Service Corporation, on behalf of its affiliates, Public Service Company of Oklahoma ("PSO"), and Southwestern Electric Power Company ("SWEPCO"), hereby submits for filing for informational purposes a 2013 Annual Update to its annual transmission revenue requirements ("Annual Update").

The Annual Update contains no expenses or costs that have been alleged or judged in any administrative or judicial proceeding to be illegal, duplicative, or unnecessary costs that are demonstrably the product of discriminatory employment practices, as defined in 18 C.F.R. § 35.13(b)(7). In addition, neither PSO nor SWEPCO has made any material changes in their accounting policies and practices from those in effect during the previous Rate Year and upon which the current rate is based.
